This Established Shipping Agreement does not modify, change or discharge in whole or in part; any term or condition in the carrier's Conditions of Contract. This agreement covers a series of shipments. The cargo will not be tendered for transportation prior to seven days following signing of this agreement.</p> <p><b>Privacy Act Notice.</b> 49 U.S.C. 114 authorizes the collection of this information.
